Re: FFY 2025 TIP Amendment #12062024-07: **Amendment** to the FFY2023-FFY2026 Transportation Improvement Program (TIP) – **H.014059 US80: BRIDGES NEAR MINDEN**. This request is to add Engineering Phase funding of \$675,000 in STPFLEX Federal funds in FFY 2025. The Construction Phase is to be moved from FFY 2024 to FFY 2027. As per TIP guidelines, adding a new project phase (Engineering) and moving the Construction Phase outside the currently effective TIP program warrants a **TIP Amendment**.
