Re: FFY 2025 TIP Amendment #12062024-03: **Amendment** to the FFY2023-FFY2026 Transportation Improvement Program (TIP) – **H.012005 US80: KCS RR OVERPASS (HBI)**. This request is to add Engineering Phase funding of \$1.4M in STPFLEX Federal funds in FFY 2025. The Construction Phase is to be moved from FFY 2023 to FFY 2027. As per TIP guidelines, adding a new project phase (Engineering) and moving the Construction Phase outside the currently effective TIP program warrants a **TIP Amendment**.
